

OFF SPOTS 2019 Event Rules

1. The present Rules set out the terms and conditions of the event 'OFF SPOTS 2019' (hereinafter referred to as '**the Event**') organized as part of the 12th edition of the International Festival of Independent Cinema MASTERCARD OFF CAMERA held in Cracow between April 26th and May 5th, 2019 (hereinafter referred to as "**The Festival**"). The Organizer of the Event and the Festival is the OFF CAMERA Foundation with its registered seat in Cracow, ul. Karmelicka 55/7, 31-128 Kraków, KRS nr 0000428063 (hereinafter referred to as "**the Organizer**").
2. The event shall be held during the Festival that is between April 26th and May 5th, 2019.
3. The Organizer shall simultaneously be the organizer of the event 'MASTERCARD OFF SPOTS 2019', targeted for entrepreneurs. Entrepreneurs participating in the event shall be operators of various business in Cracow active during the Festival i.e. restaurants, bistros, bars, bakeries, cafes, clubs, pubs, wine shops, barber & hairdressing salons, beauty salons, boutiques, perfume shops, designer shops etc. (hereinafter referred to as "**Mastercard OFF SPOTS Partner Points**"). Information on Mastercard OFF SPOTS Partner Points participating in the event is available on the website www.offcamera.pl, on leaflets to be collected in the Festival Center and the Małopolski Ogród Sztuki, and in the multimedia kiosk in the Festival Center – together ca. 130 locations.
3. A physical person who can become a Participant (hereinafter referred to as '**The Participant**') of the event shall hold a Festival ticket/Pass or accreditation and shall make a payment at a Mastercard OFF SPOTS Partner Point with Mastercard/Maestro (bank card / cell phone payment) The ticket, pass or accreditation shall be legible (in a good condition). If they are issued for a particular person (festival pass or name accreditation), the person entitled to participate in the event shall be one whose name and surname are printed on the pass/accreditation. In order to participate in the event and to receive the discount described in par. 4 below, the Participant shall inform the staff of the Mastercard OFF SPOTS Partner Point that they are interested in participating in the event.
4. Upon payment with a Mastercard/Maestro, the Participant of the Event shall be entitled to receive a discount of 10% on the price indicated in the price list of the MasterCard OFF SPOTS Partner Point.
5. We hereby inform, that the Personal Data Administrator shall be 'OFF CAMERA Foundation', with its registered office at ul. Karmelicka 55/7, 31-128 Kraków, registered in the Register of associations, other social and professional organizations, foundations and public healthcare institutions and the Register of entrepreneurs of the National Court Register led by the Circuit Court in Kraków – Śródmieście, XI Economic Division of the National Court Register under KRS 0000428063, NIP: 677-237-04-09, REGON 122633050. Personal data shall be processed in order to provide the sale of Festival passes, process the payment, and complete all tax, financial and accounting obligations, as well as for purposes related to bringing possible claims or defense against claims. 6. The present Rules shall be the sole document defining the Rules of the Event. In case of any changes or declaring any of the provisions of the above Rules void by decision of court or appropriate government office, the remaining provisions shall remain in power and binding for the Organizer and the Participant.
